alloyed austenitic Cr-Ni Steel and Mo-Cr-Ni steel according to DIN EN 10 088-1 to 3 (e.g. 1.4541 and 1.4571).

UNSUITABLE: Materials such as copper, copper-containing alloys and unalloyed and galvanised steels are not

suitable. Under these conditions,

AdBlue® has a shelf life of at least one year.
